

TERMS OF USE

1. INTRODUCTION

Please of ("Terms") carefully read these Terms Use before using https://www.loans24.co.in/ or any other associated websites, mobile sites, or mobile applications (collectively referred to as "CARS24 Website/Websites/Services") operated by CARS24 Financial Services Private Limited, a company incorporated under the Companies Act, 2013, with its registered office at 10th Floor, Tower B, Unitech Cyber Park, Sector-39, Gurgaon, Haryana 122001, India ("CARS24" or "Company"). By accessing or using any CARS24 Services, whether as a guest or registered user ("You," "Your," "Yourself," or "User"), You agree to be bound by these Terms ("Agreement").
